Nominations for Board of Directors

The 2023 Annual Meeting of the Members of Catalyst Corporate Federal Credit Union is scheduled for Tuesday, May 2, 2023, 10 a.m. Central Time at Catalyst Corporate's office at 6801 Parkwood Blvd. in Plano, Texas. Attendance may be in-person or online via video conference. Four terms on the Catalyst Corporate Board of Directors are set to expire in 2023. The Nominating Committee members are Steven Devan, East County Schools FCU, Syed Dinar, Texas Bay CU, and Jon Hernandez, CalCom FCU. The Committee's nominees to fill the expiring terms are:

Nominations for vacancies on the Board of Directors may also be made by petition if the petition is signed by representatives of 65 or more Catalyst Corporate members. Any of the following persons may sign a petition as the representative on behalf of a member: 1) the member's President; 2) the Chairman of the member's Board of Directors; or 3) any other person designated by the member's Board of Directors for this purpose (provided that a copy of the board resolution designating such person is attached to any petition signed by such person). Members are permitted to sign petitions for more than one nominee in the same election.

Petitions and signatures may be submitted to Catalyst Corporate in hard-copy format or electronically (wisemanp@catalystcorp.org). Please note that if there are no nominees by petition, there will be no nominations from the floor at the Annual Meeting, and the nominees listed above will be deemed to have been elected to fill the designated terms that are expiring.

*Gail Enda.* Gail Enda, a member of Catalyst Corporate's Board of Directors, is also the President/CEO of American Airlines Credit Union in Fort Worth, Texas. She has been with American Airlines Credit Union since 2002, serving in various roles in the organization. She has an undergraduate degree in Operations Research and Industrial Engineering from Cornell University and an MBA from the Anderson School of Management at UCLA. She serves on the Board of Directors for ePayResources<sup>TM</sup>, Members Development Corporation and Temple Shalom of Dallas. She is also an active member of the NAFCU Regulatory Affairs Committee, CUNA Roundtable Advisory Committee, Federal Reserve of Dallas Community Depository Institution Advisory Council and Filene's Inner Circle.

Greg Harden. Greg Harden, a member of Catalyst Corporate's Board of Directors and its Asset Liability Committee, is also the President/CEO of Arizona Central Credit Union in Phoenix, Arizona. He joined Arizona Central Credit Union in 2013 as EVP & Chief Financial Officer. Prior to his tenure at Arizona Central Credit Union, he served at Corporate Credit Union of Arizona (which later changed its name to First Corporate Credit Union), where he began his credit union career in 1989. He held many positions at the Corporate, spending most of his years there as EVP and Chief Investment Officer, before transitioning to Interim President/CEO prior to leaving the credit union in 2012.
